Physical Condition Requirements

I, (Print name) , a current employee, intern or contractor of Bridgewater Interiors Detroit facility, wish to participate in the exercise center offered by Bridgewater Interiors Detroit facility. I understand the inherent risks of participating in exercise and represent that I am aware of no physical condition that could affect my ability to participate in an exercise program of my choosing, and I have received no advice from a physician indicating that I may not participate in an exercise program.

Waiver of Liability for Health Risks

This release shall be binding upon my heirs, executors, beneficiaries, administrators, and assigns.

No Nonemployee Use of Facility
